FAQ for Educators: High-Dosage Tutoring

Through your school's partnership with Tutor.com and The Princeton Review[®], selected students are eligible to receive high-quality, small-group, high-dosage tutoring. This program supports and enhances student learning with personalized attention and expert guidance. Below, you'll find answers to common questions about the program and how it can benefit the students in your classes.

How does High-Dosage Tutoring help address learning gaps?

High-Dosage Tutoring provides consistent, frequent, and individualized instruction to help students overcome learning gaps and achieve academic success.

How many students get tutored at the same time?

A maximum of four students will participate in High-Dosage Tutoring with a single tutor.

Will students work with the same tutor each time?

Yes, students will be working with the same tutor for every session.

The tutors are scheduled to meet with their assigned group every time small group tutoring occurs, so be sure to let your school tutoring coordinator know about any unanticipated schedule disruptions as soon as possible.

Will educators have access to data from tutoring sessions?

Yes, educators can access the Teacher Dashboard to view data on assessments, student participation, lessons completed, and ongoing progress.

How will the educator know what is happening during a tutoring session?

After each session, tutors record information on lessons and skills covered, student attendance and engagement, and any other observations they would like to share with the teacher.

Teachers can access all tutoring session feedback in the Session Notes section and are encouraged to review feedback regularly.

How long and how often are the sessions?

Sessions take place during the school day, throughout a semester or school year, about 3 times

a week at a scheduled time. Sessions generally take place during a subject class or extended block, an intervention or small group enrichment time, an elective period, or similar. Each session lasts 30 or 45 minutes.

The tutoring coordinator at your school will work with Tutor.com to establish the schedule.

How can classroom teachers ensure the best learning environment for their students?

Position students optimally in the classroom, allowing them to concentrate fully on their tutor and their work. Reduce distractions during tutoring sessions to maximize student attention and engagement. Ensure students turn their cameras on and have working headsets.

How are tutors selected?

The selection process is rigorous. Tutors must:

- 1. Pass subject-matter exams
- 2. Verify their education
- **3.** Be fingerprinted and undergo background checks at the county, state, and federal level
- 4. Participate in interviews and training
- **5.** Engage in ongoing session quality reviews and receive feedback from our team of instructional specialists
